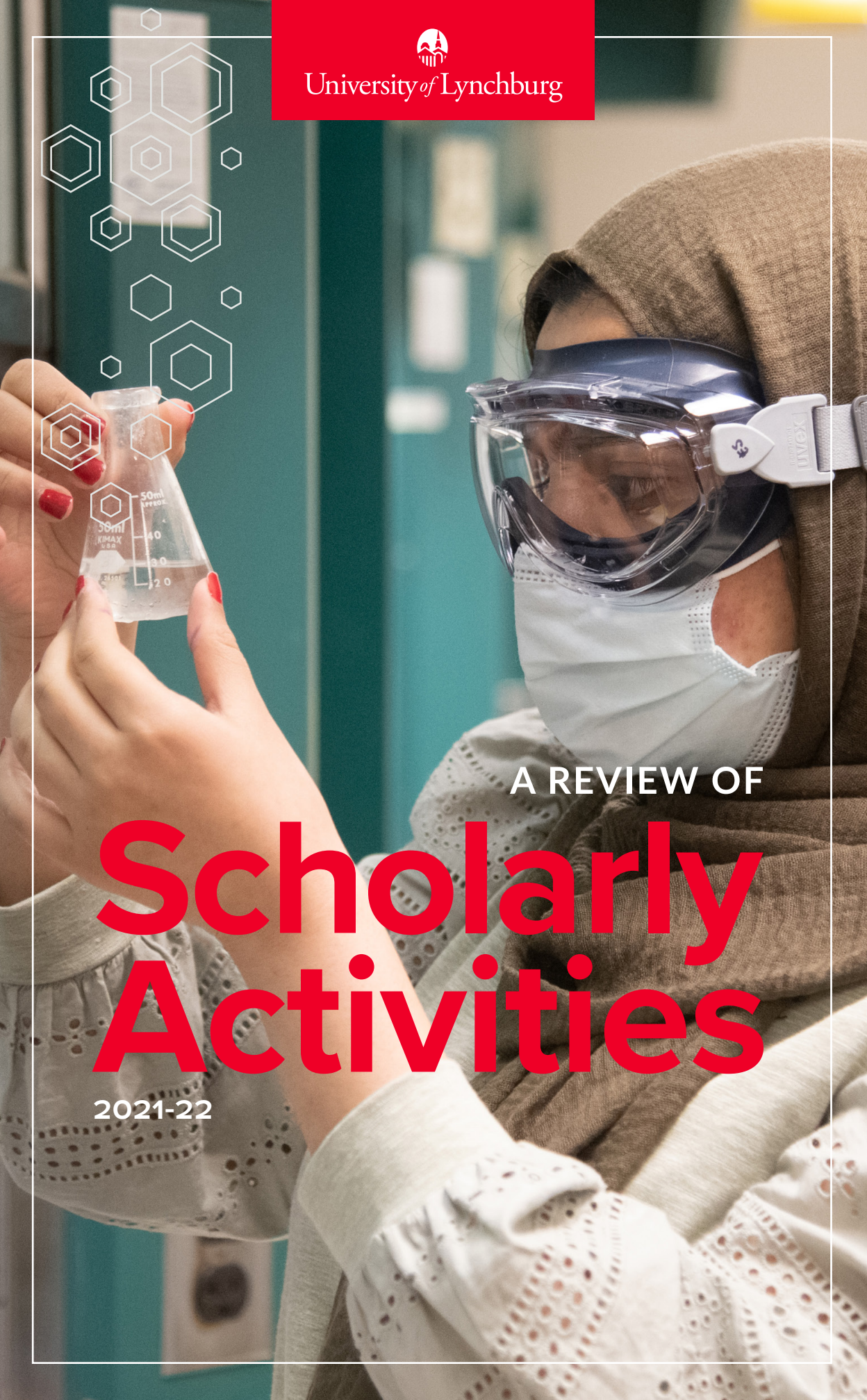

# Faculty excellence

The recipients of this year's faculty awards were recognized at a ceremony in April.

**Dr. Holly Gould**, professor of curriculum and instruction in the College of Education, Leadership Studies, and Counseling, took home two awards for 2022: the Thomas C. Allen and Heidi Koring Award for Excellence in Academic Advising and the Shirley E. Rosser Award for Excellence in Teaching.

Nomination letters referenced Gould's "caring and committed approach to academic advising," describing her as an advocate and listener for her students.

Those submitting her name said she often works irregular hours helping students on their educational path, and has lasting connections with her advisees well after they graduate. Gould's infectious passion for teaching and learning also factored into her selection for the teaching award.

Nominators emphasized Gould's ability to energize students through the challenge of online instruction during the coronavirus pandemic. Students referenced her continued availability and concern for their well-being throughout that time.

The James A. Huston Award for Excellence in Scholarship went to **Dr. Lindsay Michie**, associate professor of history, recognizing her 2021 publication of "The Spirit of Resistance in Music and Spoken Word of South Africa's Eastern Cape."

Already an established teacher-scholar with previously published work on the convergence of music and resistance, Michie's new book has cemented her expertise as an expert in that area, her nominators wrote.

They also lauded her work on establishing the John Chilembwe historical marker in downtown Lynchburg and exemplifying the possibilities of faculty-student collaborative research.

The Elsie Ervin Bock Award for Excellence in Citizenship was awarded to **Ursula Bryant**, associate professor of art, for her far-reaching involvement on campus and in the greater community. Beyond her support of students and service learning opportunities, Bryant's nominators underlined her "selfless work on multiple campus committees" and her contributions to campus.

Bryant leads by example, nominators said, delivering lectures on "citizenship and design" and promoting her work in a variety of contexts, such as presenting last year at the international STEM-STEAM Arts Humanities Social Science and Education Conference.

The 2022 Edward A. Polloway Award for Excellence in Graduate Teaching went to **Dr. Jennifer Hall**, associate professor of health promotion and public health, with the award's committee citing her "outstanding academic performance" in graduate and undergraduate settings.

A Master of Public Health student nominated Hall as “the best example of a teacher and mentor.” Among other qualities, they noted her teaching philosophy toward experiential work and focus on mitigating socioeconomic disparities associated with public health issues.

The award’s committee said that Hall’s expertise and “commitment to academic excellence” serve as success-driving inspiration for her students.

Recognized for building an “ongoing culture of research with her students,” music department chair **Dr. Cynthia Ramsey** was given this year’s Award for Excellence in Research Mentoring.

Supportive letters from past and current students said Ramsey’s mentorship was key in building their skills in performance, teaching, and research, along with an overall sense of inner confidence. Those skills, they wrote, extended well beyond their major or time at Lynchburg.

# Digging beyond her discipline

As a kid, Dr. Christie Vogler was a big fan of “Wishbone,” a children’s TV series that features a Jack Russell terrier who “brings classic literature to life and imagines himself as the live action hero in each tale.”

She “inhaled” young adult fantasy and historical fiction, and she and her brother spent hours digging in their backyard for what they called “lava rocks.” It was when Vogler’s family got their first computer, though, that her love affair with the ancients was sealed.

“I found a website that just had all this information on the Greek gods and heroes,” Vogler, an assistant professor of history at Lynchburg, said. “I would click on three links each day, print out all the information, and organize it in a folder I had in alphabetic order.”

In college, Vogler majored in anthropology. After studying abroad in Greece her junior year, her focus broadened. There, she saw archaeology firsthand and realized how mythology was “informing the lives of the ancient people.”

She wanted to combine her interests in mythology, history, and anthropology and learn more about the people who built the temples and made the pottery. “At that point, I was hooked,” she said.

In 2012, she made her first trip to Sicily to work on the Gangivecchio Archaeological Project. There, she helped excavate the site of a Roman villa that dates to the first to fourth centuries CE, or “common era.” She returned in 2015, 2017, 2019, and 2022, and used her research as a basis for her PhD thesis.

Over the years, Vogler and other Gangivecchio researchers found a host of items, including a “bone lever” used to reset a broken bone. Vogler and a colleague wondered whether this medical tool could have been used by a female doctor or healer, called a “medica.”

Vogler has seen more direct evidence that medica played an important role in ancient Roman life. One of her favorite examples is a gravestone inscription for a female doctor that indicates her husband lost both his health care and his source of income with her death.

Next year, Vogler will present about ancient female medical practitioners at the 2023 Archaeological Institute of America conference in New Orleans. She also has talked about her research on the podcast “Let’s Talk About Myths, Baby!” and co-hosts another podcast, “Movies We Dig,” billed as the “podcast about film, antiquity, and everything in between.”



At Lynchburg, Vogler is the faculty advisor of the Student Archaeological Society. She teaches Turning Points in World History, Introduction to Archaeology, Archaeology Lab, Greek Civilization, and Roman Civilization, and recently developed a new course, Gender Archaeology in the Ancient World.

Soon, Vogler hopes to share not only what she's learned at Gangivecchio, but the archaeological site itself, with her students. She wants to take students to Sicily next summer, where they'll help catalog items found on previous digs. "It's a huge goal of mine," she said.

# Closing the gap

Dr. Emma Savage-Davis, dean of the College of Education, Leadership Studies, and Counseling, is part of a multiyear research initiative alongside teacher educators from across the nation and beyond.

The Association of Teacher Educators' Inquiry Initiative launched at its summer conference in August. There, association members and external professionals grouped off and met several times to carve out areas of research to focus on through 2024.

Savage-Davis, who's been a member of the ATE since 1993 and served as president from 2014-15, said she's pleased to see it return to its roots through the initiative — a think tank of scholars helping to shape the field of education.

Specifically, this new initiative will focus on closing “opportunity gaps” and sources of societal inequality that bleed into education.

“That has been my interest for a long time and my work for a long time, in preparing teachers for that kind of space,” she said, adding that this is a prime opportunity to work with a group of professionals from across the country and internationally to focus on a specific research topic.

After the summer conference, Savage-Davis said the groups' methodology-based work will continue independently and collaboratively around those subtopics, and they'll meet again several times at each biannual ATE meeting.

Ultimately, participants will likely publish their research as scholarly articles or perhaps in a book, she said. And that work will hopefully continue and evolve even past the three years the initiative is slated for.

“This whole process is going to set the tone for the future of ATE because we're hoping ... this will add to the wealth of literature that's out there and the action that is out there,” she said.

Such contributions, Savage-Davis said, should be poised to act as agents of change to help ensure equitable and accessible education into the future.

# A new focus on research

In the fall of 2021, the University of Lynchburg announced that exercise physiology professor Dr. Jeffrey Herrick would lead its newly founded University Research Center. The center is part of the University's Lynchburg Tomorrow initiative, which includes, among other projects, the reimagining of community-based research for faculty and students on Lynchburg's campus.

As President Dr. Alison Morrison-Shetlar explained when Lynchburg Tomorrow launched in June 2021, "Lynchburg Tomorrow connects areas of need and potential in the city with our campus's unique resources, such as the expertise of our faculty, staff, and students."

Herrick, she said, is a great choice to lead the University Research Center. "I am delighted to work with Jeff on expanding our reputation on campus and as the city of Lynchburg's research hub.

"His track record as a scholar and mentor is impressive, and I am confident that he will provide excellent guidance as a researcher and expert to our students and the greater Lynchburg community."

Provost and Vice President for Academic Affairs Dr. Allison Jablonski agreed.

"I look forward to working with Jeff as he enhances the research culture of our institution, leading to greater research funding and research-friendly support," she said in an email announcing his appointment.

Herrick, who has been at Lynchburg since 2018, directs the University of Lynchburg Active Aging Program, a community-based theory-to-practice research initiative that aims to understand effective exercise program models to improve fitness, functional capacity, sleep quality, and cognitive function in older adults.

He has spent his career engaging in community-based research and has used exercise and physical activity interventions to improve health and function in a wide range of populations.

Prior to his appointment at Lynchburg, Herrick directed George Mason University's Older Adult Exercise Program, served as an associate investigator at the National Institutes of Health Rehabilitation Medicine Department, and co-directed an adult weight-management program at Southern Illinois University Edwardsville.

In addition, Herrick served as the exercise and sleep education director for the Insomnia Hub, an open-access resource center for translation of sleep research. He is in his second term serving on the American College of Sports Medicines Strategic Health Initiative on Aging.

Herrick's formal education includes a BA in psychology from Utica College of Syracuse University, an MS in kinesiology from James Madison

University, and a PhD in rehabilitation and movement science from Virginia Commonwealth University.

"I am honored to receive both President Morrison-Shetlar and Provost Jablonski's support and trust in developing and leading the University Research Center," Herrick said last fall. "I look forward to developing the center, which will aim to support and expand community-based research programs for both faculty and students."

# Global impact

Dr. Tom Bowman, professor of athletic training at the University of Lynchburg, has been named a Fellow by the National Athletic Trainers' Association Research and Education Foundation.

The award, which "recognizes national and international excellence in athletic training research and scholarship," was presented at the 73rd NATA Clinical Symposia and AT Expo held June 28 through July 1 in Philadelphia.

At the national convention, Bowman and a colleague from Ohio University also made a presentation, "Best Practices and Barriers to Implementing Concussion Rehabilitation and Patient Reported Outcome Measures."

Bowman has taught at Lynchburg since 2004. He has done extensive research on head and neck injuries in sports and athletic training socialization issues. He has published and presented extensively in these areas and has received numerous grants in support of his research.

He also has involved dozens of students in his research, along with some of the University's athletic teams. "Collaboration with students is a huge reason I think I was selected [as a Fellow]," he said. "Much of my work includes students and I've been beyond fortunate to work with incredibly bright young professionals."

Bowman's status as a Fellow will build on this. It allows him to sponsor up to five student abstract submissions each year for consideration by the NATA's Free Communication Program Committee. He must, however, be an official co-author and review and "sign off" on the abstracts.

"Dr. Bowman is consistently recognized beyond the Lynchburg community for his scholarly works and scholarly involvement," said Dr. Debbie Bradney, professor of athletic training and director of the Master of Science in Athletic Training program at Lynchburg.

"Through his research, Dr. Bowman has mentored many of our undergraduate and graduate students. If you look at his list of publications and presentations, you will see that the majority involve students.

"Due to his mentoring, the students publish and receive awards for their research projects. He is a tremendous asset to our MSAT program, the University of Lynchburg, and the athletic training profession."

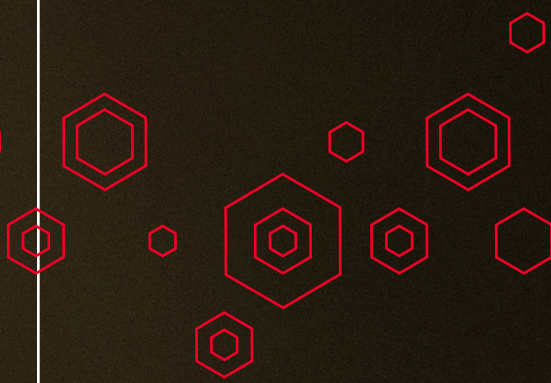
